MAJOR COURSE REQUIREMENTS:

A Honors route for graduate study in Economics requires:

- ECON 101 and 102, MATH 125, 154 and 156, STAT 161 or equivalent,
- ECON 281, 282, 299, 384, 385, 386, 387, 399, 481, 482, 497,
- STAT 161 and ECON 299 can be substituted by STAT 265, 266.
- The Honors essay route also requires 24 credits in ECON electives, including two courses at the 400 level and a capstone project, but does not require ECON 387 and 497.
- The graduate study route requires 21 credits in ECON electives.

WHAT CAN I DO WITH AN ECONOMICS HONORS DEGREE?

Graduate studies in economics, political science, or law. Research assistant, such as for the Bank of Canada.

REASON TO STUDY ECONOMICS HONORS

- 1 The program is excellent preparation for graduate studies in Economics, other social sciences, or law. As an Honors student, promotion from one year to the next requires a GPA of at least 3.0, with an average of at least 3.3 in all Economics courses.
