1. Agenda Title: **Tuition Proposals**

Approved MOTION: THAT the Board Finance and Property Committee recommend that The Governors of The University of Alberta approve a 2% increase to domestic tuition for undergraduate and graduate students for Fall 2025.

Approved MOTION: THAT the Board Finance and Property Committee recommend that The Governors of The University of Alberta approve tuition fees for new international students for all programs to take effect for the Fall 2026 intake, as set forth in the documents disseminated to the committee for its review.

2. Agenda Title: **University of Alberta Capital Plan**

Approved MOTION: THAT the Board Finance and Property Committee (the "Committee") recommend that The Governors of The University of Alberta approve the institution's Capital Plan 2025-26 - 2027-28, in the form disseminated to the Committee.
