Purpose of the Proposal: To replace the approved motion to rescind the Faculty Student Fund fee which was tied to the market modifier with a new motion to rescind the fee without any conditions.

#### Discussion:

Dean Paton noted that this fee was first established to fund a career services officer in the Faculty, a role that continues to be essential within the Faculty. He noted that both the students and the Faculty were supportive of rescission of this fee at this time.
