Weapons on University Property

Presenter(s): Marcel Roth, Director, University of Alberta Protective Services

Purpose of the Proposal: To provide an overview of the incidents of weapons and replicas on campus and discuss strategies to mitigate risk.

Mr Roth presented information regarding reported incidents involving weapons and replicas on campus. He explained standard responses by University of Alberta's Protective Services (UAPS) and Edmonton Police Services (EPS) and noted potential risk to members of the community.

Discussion:

Members expressed several comments and questions, including but not limited to: the variety of weapons involved in reports; the definition of "weapon"; potential concessions for religious items; education and training for staff; the criminal code; the importance of reasonable, informed, and educated policies and procedures; and the student discipline emphasis on education rather than punishment.
