#### 5.0 Report from the Dean

Interim Vice-Provost and Dean Epp noted that the written report, FGSR Report: Nov/Dec 2022, was included in the meeting package. He provided the following verbal comments:

#### **Unit Review:**

- We are starting to narrow down the thinking on the unit review.
- The unit review is about how FGSR positions itself within a university that is still in the middle of a reorganization; to determine where we fit within the university so that we can most effectively be partners with each of you in the work of supporting graduate students and the work of enlarging our graduate programs.
- Dr. Epp is becoming familiar with a lot of the history, the recent consultation and proposals, and the document history that has surrounded the thinking about FGSR.
- It is time to engage external reviewers on this project.
- We expect that this review will occur in early 2023.

#### **Minimum Guaranteed PhD Funding:**

- Interim Vice-Provost and Dean Epp mentioned that we will be discussing the minimum guaranteed PhD funding initiative later in the agenda, as we are currently in the information gathering stage.
- This initiative has support from the GSA and is a matter of commitment from the Interim Provost.
- There are challenges to overcome and we know it is not straightforward.
- Minimum funding guarantees are important and valuable in all kinds of ways, including that it keeps us in step with other U15 institutions.
- We are trying to see how we can make this work across the university in a sustainable and attainable way. The initiative cannot work if it results in unintended and negative consequences for parts of the university.

#### **Ukraine Conflict:**

- Prospective students joining the university in the 2023-24 year through the <u>Canada-Ukraine</u> <u>Authorization for Emergency Travel (CUAET)</u> program will be charged the domestic tuition rate instead of the international tuition rate for the duration of their program.
- U of A is one of only a few universities in Canada to offer CUAET students domestic tuition rates, which is a 70-80% reduction, depending on the program, from the international tuition rates.
- The application fee will not be waived.

#### **Iran Application Fee Waiver:**

- The pressure for a fee waiver for prospective students from Iran has been increasing and is an open and active conversation.
- We have 600+ graduate students from Iran. 1 in 6 students from our entire international cohort is from Iran.
- We are aware that applications are down sharply.
- The University is trying to move from emergency responses to global crises to a more responsive, sustainable way to support students experiencing issues.

Operational updates and reminders were included in the written report, which we encourage you to review.

#### **Discussion / Questions:**

- A Council member asked for a timeline for the unit review process as they are eager to start
  moving forward with everything in FGSR and faculties (i.e. how we organize graduate activities
  at the College versus faculty levels).
  - Interim Dean Epp mentioned that some of this depends on people's availability, but he is hoping that within the first 3 months of 2023 the review could be wrapped up.
- A Council member asked about the plan for the consultation process for the unit review.
  - Interim Dean Epp commented that there is not a plan yet, but an intention that it be done as widely as possible within the timeframe that we have.
  - Would hope that it includes Graduate Coordinators, Directors, Associate Deans, people who are working in graduate administration, and those within FGSR.
- A Council member asked about the field of questions that will be addressed during this review.
  - Interim Dean Epp commented that the primary question to be addressed is about the
    positioning of FGSR within the structure of the One University model. The secondary
    questions are around process and governance.
- Council Members asked for graduate students and supervisors as well as stand-alone faculties to be added to the list of consultations.
- A Council member commented that some international students from Iran and Ukraine were not able to meet the deadline of their departments because of the lack of internet. Departments and Coordinators need to be mindful of the issue and be flexible in these situations.
- A Council member mentioned that we need to also be flexible regarding fellowship money when attempting to recruit students from "risky" countries who may experience Visa delays. The member suggested that FGSR could allow departments to redirect fellowship money in cases like this.
- A Council member mentioned that Iranian students who are required to defer are granted a new admission letter, which comes with a 6% increase in tuition over their original guarantee. It would be helpful if we could transfer their recruitment money to a credit towards that tuition.

#### 6.0 GSA Monthly Report

Anas Fassih, GSA President, presented the GSA Monthly Report. He highlighted the Minimum Guaranteed Funding project that the GSA is working on with FGSR and the Office of the Provost. This has been a priority for graduate students for 10-15 years. The University of Alberta is lagging behind other institutions in Canada that already have funding guarantees in place. The GSA is starting with an environmental scan both externally and internally. There is a lot of variability between departments in terms of PhD funding.

GSA President Fassih updated the group on recent meetings in Ottawa with federal government officials. In these meetings, the GSA addressed their priorities including Tri-Council funding increases and mental health funding.

Currently, the GSA is developing the budget for the upcoming year.

GSA President Fassih indicated that the GSA hosted a number of social events in December. As well, they are currently processing grants and emergency funding. Finally, the Executive continues to work on their new strategic plan.

#### 7.0 Nursing: PhD Regulation and Course Changes & Masters Course Changes

Presenter: Dianne Tapp, Associate Dean - Grad, Faculty of Nursing

Interim Vice-Provost and Dean Epp invited Associate Dean Tapp to present on the proposed PhD regulations and course changes, and the Masters course changes.

AD Tapp spoke broadly about a few of the highlights of this package. These calendar changes are coming from a 3-year process of program and curriculum review of all programs in the Faculty of Nursing. The Faculty of Nursing made a decision to retain and revise the existing core courses in the curriculum rather than start over. The revisions to core courses and electives reflect the current content and contemporary focus of the doctoral program courses. The Faculty explicitly adopted the national accreditation body's guidelines for doctoral program outcomes, and they align nicely with the calendared FGSR program outcomes. They have added additional outcomes to address specific capabilities regarding reconciliation and EDI that they wanted graduates to be exposed to and confident in.

Three new one-credit courses are added as core-required courses. These are a series of courses to help build cohorts within incoming doctoral students and to build some of the soft skills that are required to help achieve overall program outcomes. They are a fantastic safety net for graduate supervisory topics. These courses are prerequisite to the doctoral dissertation seminar that will then happen in the winter term of year 2.

Finally, there is a deletion of the Residency requirement, which was unanimously approved by the Faculty of Nursing Council in October.

AD Tapp also spoke to the Masters changes indicating that the Faculty of Nursing implemented changes to the Master of Nursing curriculum in the fall of 2021. Now they are putting forward a revision to a course description as well as minor course title tweaks from courses that were introduced last year. There is a similar three one-credit Community of Inquiry series and they wanted to distinguish a Master Community of Inquiry level from the doctoral ones being introduced. Changes to the capstone project -- Nursing 900 is now going to be a guided seminar instead of an independent study.

AC Wilman outlined a change to the BioMedical Engineering program. They have three courses of which two used to come from the required course list. They have a wide variety of students and want to be able to choose the courses that are appropriate.

#### 9.0 Rehab Med: Suspension of the Graduate Certificate in Stroke Rehabilitation

Presenter: Bernadette Martin, Associate Dean - Rehabilitation Medicine

Interim Vice-Provost and Dean Epp invited Associate Dean Martin to provide an overview of the proposal.

AD Martin outlined the reasons for the proposed suspension of the Graduate Certificate in Stroke Rehabilitation. The certificate has been up and running since 2010. The challenge has been a lack of enrolment, as the original targets have never been reached. In the last few years, they have found that the number of applicants and learners completing the certificate has significantly decreased to the point where it is not financially viable.

#### 10.0 Rehab Med: Suspension of the Graduate Certificate in Bridging to Canadian Physical Therapy Practice

Presenter: Bernadette Martin, Associate Dean - Rehabilitation Medicine

Interim Vice-Provost and Dean Epp invited AD Martin to present the proposal.

AD Martin outlined the history of the certificate indicating that it was funded for the first four offerings through a Health Canada grant. The certificate was well subscribed with 25 – 30 internationally educated Physical Therapists in each cohort. They have found that although it is a good program, it is too expensive for this population of learners and the enrolment has dropped significantly. They intend to roll out a non-credit new curriculum in this area.

#### 11.0 East Asian Studies: Entrance Requirement Changes

Presenter: Kim Noels, Associate Dean – Graduate, Arts

Interim Vice-Provost and Dean Epp introduced Associate Dean Graduate Kim Noels to present the proposed entrance requirement changes.

AD Noels indicated that the Department of East Asian Studies currently requires all entrance students to have four years of university-level study in a language that will be the focus of their graduate degree. The department would like to reduce that to three years to improve recruitment. East Asian Studies' own undergraduate program only requires three years of language study. This approach would be much more consistent with their own program and other programs across Canada.

#### 12.0 MMus Performance and Choral - Calendar Changes

Presenter: Kim Noels, Associate Dean – Graduate, Arts

Associate Dean Graduate, Kim Noels outlined the proposed calendar changes. The Department of Music would like approval for some changes to the Masters of Music in Choral and Performance programs. They would like students to take at least one academic course. It was felt that a requirement that would ensure students complete an academic paper before they graduated was important for that degree.

#### 13.0 Joint Degree Agreements with IIT Delhi, IIT Kanpur, and IISC

Presenters: Cen Huang, Vice-Provost & Associate Vice-President (International) and Shawn Heinz, Senior International Agreements Administrator, UAI

Interim Vice-Provost and Dean Epp invited AVP University of Alberta International (UAI) Cen Huang to present information about the three joint degree agreements.

AVP Huang indicated that these proposals were part of a group of these agreements that were approved at the October 2019 FGSR Council meeting. These three new agreements are proposed now because they were not ready in 2019 when the other programs were approved. They expect students will finish their candidacy exam or evaluation on the Indian side and then would come to the University of Alberta to do research aligned with their dissertation. The research will be jointly supervised by IIT and U of A professors. When students complete one year of PhD research at the University of Alberta, they will go back to their home institution to get a PhD degree from IIT. AVP Huang stressed that the institutions we are proposing joint degrees with are the top universities/ institutions in India.

Interim Dean Epp added that the agreements had received a legal screen/review.

Motion: Be it resolved that FGSR Council approve the Joint Doctoral degree agreements between UAlberta and each of: IIT Delhi, IIT Kanpur, and IISC, for implementation upon final approval, including approval by the Dean of FGSR, and signature by the UofA and each institution.

#### **Questions/Discussion:**

- A Council member mentioned that at PRC they discussed ideally completing the candidacy exam
  and all the course requirements at the home institution prior to visiting the collaborating
  institution; however, agreement does provide provision for taking courses at the collaborating
  institution if approved by the student's supervisory committee. Our understanding is that this
  does not comply with the University of Alberta calendar and taking required courses at the
  collaborating institution would put the student's degree at risk. One way around it is to say
  courses taken at the collaborating institution are extra to the degree.
  - Vice-Dean Ali Shiri clarified that it is expected that students will successfully complete all
    their required courses and their candidacy exam at their home institution before visiting
    the collaborating institution. It is implied that they need to complete required courses
    as reflected in the University calendar. If there is going to be an additional or separate
    set of courses, they would need to be approved by supervisors from the home
    Institution and the visiting institution.
  - AVP Huang indicated that they would take these points and revisit the language in this
    particular section of the agreements.
  - The Chair mentioned that the motion would allow for editorial revision with Deans sign off.
- A Council Member questioned what the financial impact is on the University of Alberta for a program like this.
  - AVP Huang indicated that the agreement is built as a reciprocal exchange and the U of A
    provides a stipend to students. Jointly funded by UAI and the Provost's Office at a value
    of \$50,000 per year.
- A Council member asked how many University of Alberta students are at IIT Institutions
  presently. As well, the member asked about the number of members on the supervisory
  committee.
  - AVP Huang indicated that no students are presently at IIT, but they will be promoting this opportunity.

#### 14.0 ALES: RENR Changes

GC Hamann indicated that these changes are mostly small administrative clerical changes. The first one is in regards to a qualitative course requirement for thesis-based programs. They used to have a three-credit single course, quantitative requirement, but subsequently changed this to a one-credit module, so all quantitative courses are now given as one-credit modules and still have to take two. It turned out that those one credit modules were actually better reflected as 1.5 credit modules because they are given in half a term, and students can choose what they need. They want to up these to 1.5 and revert to the three-credit quantitative requirements.

#### 15.0 ALES: RENR Academic Standing Change

Previously they have required a 3.0 grade point average instead of 2.7 for students to go forward to graduate. It is not something supervisors want anymore and this requirement has been neglected for years. They want to default to the normal 2.7 of FGSR as this simplifies everything.

#### 16.0 Early Idea Generation: Minimum PhD Guaranteed Funding

Interim Vice-Provost and Dean Epp introduced the item indicating that we are very much in the information-gathering stage right now, and gathering both U15-related and internal data. The GSA has done some helpful work related to this initiative. We want to get as close as we can to identify potential gaps and risks at the program level. We have many data sources, but what is most important is a profile of PhD students. If, when completing the FGSR survey, you find that the numbers are hard, spend your time on building the profile and identifying risks and gaps. We want the exposure of the university to be minimal. We will be collecting data from multiple sources and comparing it, and many things have changed since we did some of this work in 2018/2019.

#### **Questions/Discussion:**

- A Council member mentioned that they are part of a new PhD program focused on work and employment. They worry about small programs having to provide guaranteed funding.
  - Interim Dean Epp indicated this feedback is consistent with what we have heard and we recognize there is a funding gap that needs to be made up in order for this not to simply be a way to produce winners and losers.
- A Council member indicated that they are surprised that the guaranteed funding package is so different from the GSA agreement. The member asked how we arrived at the number of \$18,000 and also raised the issue of differential fees, as international students are incredibly disadvantaged because they do not qualify for Tri-Council funding. If we are going to have a funding guarantee, we should probably have a separate equation for international students.
- A Council member indicated that they are from a small program with the same concerns mentioned previously. Alberta government funding is very inflexible now and that will be a challenge. They noted that the University of Alberta could consider a tuition waiver as part of the funding package as it would simplify the process for departments.
- A Council member mentioned that they worry that without some additional funding sources to complement our capacity to fund doctoral students internally they will have to decrease the number of doctoral students. This decrease would have a real impact on their reputation and program.
- A Council member mentioned a concern with the survey is that each question is required. They
  also indicated support for the idea of a tuition waiver. The member raised an additional concern
  that there are instances where tuition costs for course-based programs are the same as thesisbased programs.
  - Interim Dean Epp indicated that FGSR will adjust the survey so not all questions are required.
- A Council member indicated that they do not see a solution to this issue without some central funding.

- A Council member indicated that we should approach this initiative as an opportunity to advocate for students and programs. Rather than be scared, we need to push very hard for additional funding.
- A Council member mentioned that it is important to remember that graduate students receive tax credits when they pay their tuition. They would rather allow them to have a funding package and then pay tuition with that tuition package.
- A Council member indicated that there are financial ways to make this happen. The University of Calgary has had a give back on their tuition for a while.
- A Council member mentioned that tax related issues need to be examined (i.e. would the tax credit idea apply to international students). Also mentioned that they recall that Alberta does not do tuition tax credits anymore.
- A member mentioned that there is not a clear purpose statement telling why we would provide
  minimum funding for students. A tuition waiver is better than tax credit because students do
  not get all of tuition back when claimed. Scholarships often come too late for recruitment and
  are instead viewed as a reward.
- A member mentioned that finding out where the University of Calgary is receiving their funding might be a starting point for this initiative.
- A Council member mentioned that at the University of Calgary there were centrally distributed funds for graduate students. There has been a long-standing central commitment for graduate students at the U of C.
- A member commented that the Faculty of Medicine at the University of Calgary has been much more effective in their fundraising efforts.
- A member indicated that we need to think what is the minimum to be "international and relevant" with regards to having international students. Do we need 40% international students to be a "global university"?
- A Council member mentioned that they have heard multiple references to central funding as if there is central funding. We need to have different conversations at this university about funding priorities. This is about the budget process.

#### 17.0 Question period

Professor Heather Coleman raised a question about whether the deadline for completing the ethics course could be extended.

Associate Dean Doug Gleddie asked about the scheduling of the next GEFAC meeting.

Interim Vice-Provost and Dean Epp acknowledged and thanked all the members of FGSR Council for their time, attention, and really good contributions at today's meeting. He mentioned that FGSR will be hosting an Open House on December 13<sup>th</sup>, and invited Council members to stop by
