Excused Absence Request Form

Application for Excused Absence from Term Work and Final Exam Deferrals

- This form is to be completed by a student missing term work (e.g. seminar, laboratory and midterm examinations) worth greater than 5% of the total grade or <u>a Final Exam</u>, where an excused absence is being sought.
- This form is to be completed for planned and unplanned absences.
- The request will be reviewed and judged in context with the University regulations outlined in the <u>calendar</u>.
- Excused absences are not automatically granted.
- Planned absences will only be considered if the request was submitted within 2 weeks of the start of Fall or Winter classes and within 3 days of the start of Spring or Summer classes.
- In all cases, the Faculty may request adequate documentation to substantiate the reason for the absence.
- Students and Instructor(s) of record will be notified as to the decision and how the situation will be handled by email.
