3. Comments from the Chair

The Chair acknowledged the recent issues raised regarding online homework, and noted that discussions were ongoing to ensure compliance with tuition fee regulations and to ensure no hardship was created for students. No cost options will be explored with publishers. The Chair explained that he will be working with Mr Fahim Rahman, Vice-President (Academic), Students' Union (SU) to explore this issue further. He added that he will be organizing a working group to develop a procedure surrounding what percentage of a grade can come from third party assessment, under the University of Alberta's Assessment and Grading Policy. It was noted that instructors should feel free to use questions from text books as part of the student assessment as it is the instructor, rather than a third party, who grades these assignments.

5. <u>Proposal for Changes to Existing Entrance, Academic Standing and Language Requirements for</u> graduate programs in the Department of Modern Languages and Cultural Studies, Faculty of <u>Graduate Studies and Research</u>

Presenter: Victoria Ruetalo, Associate Professor, Faculty of Arts; Lynne McGarvey, Vice and Associate Dean, Faculty of Education

Purpose of the Proposal: To discuss proposed changes to Entrance, Academic Standing and Language Requirements for graduate programs, Department of Modern Languages and Cultural Studies.

Discussion:

Dr Ruetalo noted that the Department of Modern Languages and Cultural Studies has recently undergone a rigorous review aimed at improving sustainability; the proposal would collapse the graduate program into four second level specializations, which would bring together the different areas and languages in the Department.

Dr Ruetalo reported that the entrance requirements, academic standing requirements and language requirements have been updated. She emphasized that the proposed changes represent a restructuring of the current model, and noted that the proposal was vetted extensively throughout the consultation process.

There was a discussion around the entrance requirements based on GPA attained over the last *60 or two years of study. The proposers agreed to amend the requirement to specify the last *60, and remove the reference to two years.

Dr Ruetalo provided the reasoning behind the language requirement within the proposal, noting previously students had entered the program with competency in two languages. The addition of Comparative Literature students in the program who would not automatically have this competency, has led to the proposed change.

6. <u>Proposal for a (new) Freestanding For-Credit University Certificate in Early Childhood Education.</u> <u>Faculty of Education</u>

Materials before members are contained in the official meeting file.

Presenter: Anna Kirova, Professor, Elementary Education; Lynne McGarvey, Vice and Associate Dean, Faculty of Education

Purpose of the Proposal: To discuss the proposed University Certificate in Early Childhood Education.

Discussion:

Dr McGarvey gave a brief overview of the three University Certificates proposed by the Faculty of Education by noting that that all of the proposed certificates are established the same way, and provide an opportunity for professional development of in-service teachers. She added that these are revenue generating programs, and that there was extensive consultation conducted during the development of these proposals. She reported, specifically, that the certificates have earned support from the Provincial Government as well as the Alberta Teachers' Association.

The proposed University Certificate in Early Childhood Education provides professional development for inservice teachers and child care providers in the licensed and regulated child care setting through courses aimed to develop the specialized knowledge and skills required to effectively teach young children. Dr Kirova noted that this certificate is unique, and is responsive to the Provincial Government's commitment to early childhood education and development. The program is based on a recent study entitled The Early Childhood Mapping Initiative Alberta and would improve the qualifications of professionals who work with young children in licensed child care centres, and as well, to address the increased need for these professionals. She reported that this certificate will provide professionals an opportunity to earn required educational upgrades.

In response to a question about admission criteria, Dr Kirova confirmed that applicants could be admitted with a Bachelor of Arts.

Dr Kirova provided further information to members in regards to the cost assessment of the certificate, noting that the \$850 fee was discussed with the Provincial Government. It was noted that this tuition level was lower than that proposed for the other certificates; this was a reflection of the average salaries of potential students in early childhood education as compared to teachers in grade schools.

In response to a question of whether these courses could be applied towards a Bachelor of Education, Dr McGarvey replied that there would be future discussions at the Faculty about this.

7. <u>Proposal for a (new) Freestanding For-Credit University Certificate in Advancing Adolescent Literacy</u>

Materials before members are contained in the official meeting file.

Presenter: Rauno Parrila, Professor, Educational Psychology; Lynne McGarvey, Vice and Associate Dean, Faculty of Education

Purpose of the Proposal: The certificate in Advancing Adolescent Literacy (AAL) provides secondary school teachers with the knowledge and skills required to effectively support students' ongoing growth of literacy skills in grades 7 to 12.

Discussion:

Dr Parrila reported that this certificate addresses the current need for professional development for teachers in the area of adolescent literacy, in light of recent statistics indicating that 48% of young adults possess inadequate literacy skills. He reported that the Provincial Government has provided funding for this specific certificate, and that it is unique in North America.

In terms of the program, he noted that it is intended for existing secondary school teachers to earn on a part-time basis and includes five online courses. He explained that the certificate includes a mentorship component which is anticipated will have students sharing this knowledge with their teacher colleagues.

8. <u>Proposal for a (new) Freestanding For-Credit University Certificate in Digital Learning, Faculty of Education</u>

Materials before members are contained in the official meeting file.

Presenter: Patricia Boechler, Professor, Educational Psychology

Purpose of the Proposal: The Certificate in Digital Learning will provide current in-service teachers and educational professionals with University credit-based professional development coursework in the area of digital learning. This supports and aligns with five core policy directions of Alberta Government's Learning and Technology Policy Framework.

Discussion:

Dr Boechler provided members with an overview of the proposal, noting that the certificate is targeted towards current teaching professionals who may require professional development in the area of digital literacy in the K-12 educational setting.

She reported that this certificate has been well supported by all provincial and federal groups involved in its development, and that is aligns with the standards of the Provincial Government in particular. She noted that in a recent survey, only 30% of Alberta teachers reported sufficient knowledge to promote digital literacy.

A member noted that the new course designator would require approval through the GFC Executive Committee. In regards to questions surrounding the cost of this certificate, the Chair clarified that the Committee's mandate does not include the budget.

In response to a question about admission criteria, Dr Boechler noted that applicants do not need, specifically, to hold a Bachelor of Education.

Dr Boechler thanked members for their support of this certificate, and stated that the program would be following-up with graduates to see if a mentorship component would be useful in the future.

9. <u>Proposal for an Embedded Credit Certificate in Real Estate, Faculty of Business</u>

Materials before members are contained in the official meeting file.

Presenter(s): Elaine Geddes, Associate Dean (Undergraduate Programs), Alberta School of Business; David Dale-Johnson, Executive Professor, Alberta School of Business

Purpose of the Proposal: To establish an embedded Certificate in Real Estate to provide Bachelor of Commerce students the opportunity for a broad based education in real estate economics, finance, law and development preparing them for a range of careers in the real estate industry.

Discussion:

Professor Geddes introduced Mr Dale-Johnson, the Stan Melton Chair in Real Estate at the Alberta School of Business, and acknowledged that this certificate was developed with his expertise.

She reported that the certificate was developed in response to student demand and demand from industry professionals for more programs in the field of real estate. She noted that although the certificate being proposed is open to Alberta School of Business students only, her hope is to eventually open up the program to students from other programs.

Mr Dale-Johnson explained that this proposal has received wide support from the real estate industry and that students with this educational background are in high demand in the fields of construction and finance, as well as a broad range of other areas.

Following a comment of support, a member noted that in addition to the Bachelor of Arts in Planning, that there is also a Bachelor of Science in Planning.

In response to a question regarding courses, Professor Geddes clarified that students who wish to complete this embedded certificate must do so within the confines of their program, without adding additional courses. She noted that, due to limited resources, this policy is in place across all programs in the Faculty.

The Chair pointed out that there are two Motions in relation to this proposal, including the update to the University Calendar in relation to the termination of the non-credit Certificate in Real Estate. Professor Geddes noted that certificate was created for industry professionals but that there was subsequently no enrolment in the program and the program was never offered. The Chair clarified that this Motion relates to the change to the University Calendar.
