3. Comments from the Chair

The Chair noted that Dr Peter Mahaffy and Dr Art Quinney, co-chairs of the Campus Alberta Quality Council (CAQC) have been invited to speak to the committee in April or May on the expectations of CAQC regarding learning outcomes.

The Chair reported that the Provost, Kate Peters, and he had met with Advanced Education to discuss cost recovery programs and tuition fee regulation (TFR) exempt programs. He indicated that government would not support proposals that seek to be TFR exempt. Cost-recovery programs (including professional masters) will be reviewed on a case-by-case basis, but a strong case needs to be made for each program. Members discussed the rationale for setting higher levels of tuition including marketplace comparisons and whether there were any programs in the province or if students had to go to an institution outside of the province for the program.

The Chair further commented on on-going conversations regarding digital learning resources and noted the importance that students not be disadvantaged by such a requirement.

5. <u>Faculty of Medicine and Dentistry: Proposed changes to existing academic standing regulations, MD</u> program

Materials before members are contained in the official meeting file.

Presenter: Fraser Brenneis, Vice-Dean (Education), Faculty of Medicine and Dentistry

Purpose of the Proposal: To clarify the academic and professional standards to which students are bound, as well as to clarify previously ambiguous sections of wording regarding promotion, reexaminations and academic standing.

Discussion:

Dr Brenneis explained that the MD program is different from most other programs because the first two years consist of a series of courses taken sequentially, with a mandated number of hours of lecture, lab, small group work, and independent study. In addition to this, there are a few courses that will span the entire year. In such an environment, when a student is unsuccessful in an exam, it is difficult to carry on with their courses and there are not many opportunities to re-take an exam. The proposed changes will allow a re-examination to happen earlier if it will benefit the student.

On the next item, Dr Brenneis noted that students must eventually be accredited according to the CanMEDS (Canadian Medical Education Directives for Specialists) framework of 7 roles, one of which is Professionalism. This indicates that the Faculty should be providing some instruction on how to become a professional; the proposed changes are in line with other MD programs across the country. The proposed changes will ensure that students are aware that they are expected to abide by a Professional Code of Ethics.

A member asked why students would request a re-examination if they passed in a pass/fail system. Dr Brenneis responded that this wording will provide clarity that students are not allowed to re-write a passed examination because some students do request it. It was noted that the Faculty has been asked to put some numbers behind the pass/fail because some scholarships require a minimum average. In response to a question, Dr Brenneis noted that the appeal process was listed elsewhere in the calendar.

A member asked if attendance was part of student evaluation. Dr Brenneis noted that absences are handled with the attendance policy; but that due to the nature of some courses, a student could fail a course if the absence prevents the student from attaining the outcomes necessary in the course. A friendly edit was made to the calendar wording to provide consistency and clarity.

6. <u>Faculty of Rehabilitation Medicine: Proposed changes to existing admission / academic standing regulations (Professional Ethics)</u>

Presenter. Liz Taylor, Professor and Associate Dean (Programs and Teaching), Faculty of Rehabilitation Medicine

Purpose of the Proposal: Changes are being made to the Professional Ethics / Code of Student Behaviour section of the FRM Faculty Regulations to extend expectations of professional conduct into the admissions process.

Discussion:

Dr Taylor explained that Rehabilitation Medicine is a very competitive program and that not all applicants with a high GPA are considered to candidates for good health care providers. In the application process, the Faculty has experienced unprofessional or inappropriate behaviour or communication on the part of applicants towards staff. It was noted by another member that this was also an issue in other faculties. Dr Taylor noted that the proposed changes will make it clear to students that they will be subject to the professional ethics from the time of application.

Committee members noted that this is an important message that should be shared widely, not only for high school students, parents and guidance counselors, but also at the University through student groups.

A member noted that these issues are common in any type of professional program and that support staff have to deal with the majority of them. It was suggested that this wording be added to the general University Calendar.

In response to a question on how this would be different from the Code of Applicant Behaviour, it was noted that the Code of Applicant Behaviour deals mostly with items such as falsifying documents, rather than a professional conduct.
