5. <u>Proposal for an Embedded Graduate Certificate in School Administration Leadership, Faculty of Graduate</u> Studies and Research and Faculté Saint-Jean

Purpose of the Proposal: This proposed certificate includes four courses (total \*12) in the certificate will give students a deeper understanding of leadership in school administration. They are offered in French and will look specifically at Francophone and French Immersion Education.

Dr ElAtia summarized the development of this proposal and indicated that it had received strong support from internal and external stakeholders. She noted that the formal recognition offered by this certificate would benefit students moving into school leadership roles. Dr ElAtia further noted that this could be further developed into a freestanding certificate in the future.

6. <u>Proposed changes to Existing Admission Requirements, Master of Education and doctoral programs in the Department of Secondary Education, Faculty of Graduate Studies and Research</u>

*Purpose of the Proposal*: The Department of Secondary Education is raising the admission GPA requirement for the doctoral programs to 3.5 and for both master's and doctoral programs raising the required TOEFL score to 580 (paper-based) or equivalent.

#### Discussion:

Dr Adams explained that this proposal changes the admission GPA to 3.5 and updates to the English Language Proficiency (ELP) standards to align with other departments.

# 7. <u>Proposed Changes to Existing Admission Requirements, Dental Hygiene Post Diploma Degree</u> Completion Program, Faculty of Medicine and Dentistry

*Purpose of the Proposal*: To provide clarity around admission requirements due to the removal of the Dental Hygiene Diploma Program information from the University Calendar.

#### Discussion:

Dr Brenneis explained that various changes to the course requirements in the diploma program over a number of years resulted in different levels of preparedness for entry into the post diploma degree completion program. Thus, different admission requirements were necessary based on the year of graduation from the diploma; this proposal clarifies these requirements.

Purpose of the Proposal: Changes proposed here include reworded sections pertaining to students entering the newly reorganized BSc Program in Fall 2017, while retaining wording specific to students currently completing the Dental Hygiene Diploma Program and the BSc (Dental Hygiene Specialization) where necessary.

#### Discussion:

Dr Brenneis noted that there will be two cohorts in Dental Hygiene at the same time; one will be in the diploma program and the other in the degree program. The proposal clarifies the different academic regulations related to each cohort. During the discussion it was noted that there was some inconsistencies in the name of the program and that some of the information included was not necessary. Dr Brenneis agreed to withdraw the item to make the suggested changes. It was agreed that the revised item would be circulated to the committee electronically for approval.
