Purpose of the Proposal: To seek approval of the suspension of admission/transfer to majors in the Bachelor of Arts (BA) offered by the Department of MLCS to be activated upon approval of the proposed new major in MLCS.

Discussion:

Dr Smith-Prei reported that this proposal seeks suspension of admission and transfer into the current 8 majors offered by the Department of Modern Languages and Cultural Studies (MLCS). She noted that these programs will be replaced by an umbrella major in MLCS which will consolidate the current offerings to afford students the opportunity to study multiple languages, provide more interdisciplinary opportunities, and increased flexibility for the department.

During the ensuing discussion, members sought clarification around the timing of the two proposals, and the process of consultation with both undergraduate and graduate students. Dr Smith-Prei noted that students had expressed concern about parchments for the new program and that it would be addressed.

Purpose of the Proposal: To provide clarity to the Academic Standing "Promotion and/or Continuation" regulations in the Doctor of Pharmacy (PharmD) for Practicing Pharmacists program.

Dr Brocks noted that this proposal specifies the maximum number of experiential courses that students can fail before being Required to Withdraw.

Members discussed the timing and type of feedback provided to students as well as the appeal process for noncredit courses. There was a discussion on the clarity of the proposed wording.
