5. <u>Proposed Changes to the Doctor of Medicine (MD) Program Admissions for Aboriginal Applicants,</u> Faculty of Medicine and Dentistry

Presenter(s): Shirley Schipper, Vice Dean, Education, Faculty of Medicine and Dentistry (FoMD); Tracey Hillier, Associate Dean, MD Program, FoMD; Sita Gourishankar, Assistant Dean, Admissions, MD Program, FoMD; Tibetha Kemble, Director, Indigenous Health Initiatives Program, FoMD

Purpose of the Proposal: The purpose of this proposal is to increase the number of Indigenous students admitted to the MD program and, by so doing, work towards increasing the number of Aboriginal professionals working in the healthcare field (Call to Action #23 of the Truth and Reconciliation Commission, 2015).

Discussion:

Dr Schipper explained that all of the Faculty of Medicine and Dentistry programs were working on their admissions processes to increase the number of Indigenous students and thus Indigenous health professionals as recommended in the Truth and Reconciliation Commission's (TRC) Calls to Action.

Ms Kemble spoke about the importance of the TRC's Calls to Action regarding health care and the current health crisis in the Indigenous community. She also noted that a change in the admissions process would not hurt the reputation of the Faculty of Medicine and Dentistry. She explained that the Indigenous application process required that students meet the admission requirements but that fit for the program was assessed in a more culturally appropriate manner.

During the discussion members expressed several comments and questions, including but not limited to: the Admissions Committee having the final word on admissions because of accreditation requirements; the membership of the Indigenous Admissions Committee and the Admissions Committee and the collaboration between the two as well as member intent; and the removal of the reference to a prescribed number of seats for Indigenous applicants.

Members asked about student re-examinations and academic standing. Dr Patterson emphasized the small student numbers in the program and noted that there was close communication with students on an individual basis.

Purpose of the Proposal: The proposal is before the committee because after suspending the Dental Hygiene Diploma Program in 2016, a modification to the post-diploma degree completion program was required going forward, to continue only admitting U of A diploma graduates. The modifications in the academic regulations section were necessary for the new BSc program but the essence of the meaning of each regulation remains the same as for the previous diploma program.

Discussion:

Dr Compton indicated that the diploma program was terminated in July 2017 and the last student graduated in 2018 and the program was removing reference to it in the University Calendar.

Members enquired about the diploma completion program that was available only to University of Alberta graduates and the phasing out of that program.

12. <u>Increase to Required English Language Proficiency (ELP) Scores for Undergraduate Admissions -</u> Alignment Across Tests

Presenter(s): Melissa Padfield, Interim Vice-Provost and University Registrar

Purpose of the Proposal: To make changes to the secondary ELP tests (less commonly used) to align with the 2017 approved proposal for IELTS and TOEFL scores. This alignment will better support undergraduate student success and increase the likelihood of improved academic outcomes. The proposed changes are supported by research undertaken by the Office of the Registrar.

Discussion:

Ms Padfield noted that the changes to the IELTS and TOEFL had already been approved and that they were the most commonly used tests. The proposal was to adjust the calibration of the other ELP tests to align properly.

Members asked about the ELP standards for all undergraduate programs; the discontinuation of the paper-based TOEFL exam; consultation with students; and the expectation that minimum scores would be higher in the future.
