3. Comments from the Chair

The Chair invited members to introduce themselves and welcomed members to the first meeting of the year. He then provided members with a brief overview of the mandate and Terms of Reference of the Committee. The Chair reminded members about the change of meeting time for this term only.

ACTION ITEMS

4. <u>Appeal of Violation Notice to the Discipline Officer – Proposed Changes to Section 30.5.6(2)</u> (Violation Notice Procedures) of the Code of Student Behaviour

Materials before members are contained in the official meeting file.

Presenter: Deborah Eerkes

Purpose of the Proposal: To give the Discipline Officer discretion to vary the fines on 'Violation Notices' when a student appeals.

Discussion:

Ms Eerkes provided members with a brief summary of the proposal, noting that during its development, it was vetted through all relevant stakeholders, including the Students' Union (SU) and various senior administrative offices at the University of Alberta.

She explained the history surrounding the initial changes to the Code of Student Behaviour, enacted in 2007, in relation to the ability of Discipline Officers to hear student Violation Notice sanction appeals, as opposed to convening full University Appeal Board (UAB) hearings. She added that the changes made at that time only allow Discipline Officers to uphold the original ticket or dismiss the charges, and that

consultation with stakeholders has revealed their wishes for the Discipline Officer to have authority to vary the sanctions.

During the discussion surrounding this proposal, members provided a number of questions and comments, including, but not limited to: clarification about the frequency of appeals; support for this proposal; discussion surrounding the implementation date for such amendments to the Code of Student Behaviour.

THAT the GFC Campus Law Review Committee approve, under delegated authority from General Faculties Council, proposed revisions to Section 30.5.6(2)e.ii (Violation Notice Procedures) of the Code of Student Behaviour, as submitted by the Director of the Office of Student Judicial Affairs (OSJA) and as set forth in Attachment 1, to take effect upon final approval.

5. <u>Proposed "Housekeeping" Changes to the Residence Community Standards Policy</u>

Purpose of the Proposal: To update the Residence Community Standards Policy to enact the recommendations of Residence Services. The proposed revisions are viewed by Residence Services as minor and editorial (or "housekeeping") in nature.

Mr Richardson reported on the proposed changes, noting that they are minor in nature, and mostly comprised of changes to language within the Residence Community Standards Policy. He provided a summary of the changes to members. He clarified that the proposed changes are editorial in nature.

A member suggested that the proposers should provide a brief summary of the changes as an attachment to future proposals of this nature.

He noted that the institution of Restorative Justice practices, including the increased utilization of mid-level meetings, has improved the ability to appropriately respond to residence conduct issues.

Members expressed a number of questions and comments in relation to this Report, including, but not limited to: that the Report findings support the continued improvement of incidents; clarification surrounding how cases are referred; whether there could multi-year comparative data provided in future reporting.
