ACTION ITEMS

4. Changes to Section 30.5.2(6) of the Code of Student Behaviour: Appeal of Declining to Proceed with a Complaint

Presenter: Deborah Eerkes, Director, Office of Student Judicial Affairs

Purpose of the Proposal: To simplify and make more efficient the current appeal of a decision not to proceed with a complaint under the Code of Student Behaviour (COSB) while maintaining the required fairness of the process.

Discussion:

Ms Eerkes reported that the current process to appeal a decision not to proceed with a complaint under the Code of Student Behaviour (COSB) is resource-intensive and inefficient. She stated to members that a change to section 30.5.2(6) of the COSB would save both time and resources for the University without compromising fairness. A working group (comprised of the Office of Student Judicial Affairs (OSJA), General Counsel, Residence Services, an Associate Dean, the Student OmbudService and the Appeals and Compliance Officer) was created to review this section of the Code and identified a number of issues, including: that the Unit Director is redundant; the process to appeal a Dean's decision not to proceed should stay within the Faculty; constituting a three person panel is time consuming and unnecessary. In addition, under the current model, she noted, if the three-person panel were to find that the matter should proceed, the Discipline Officer does not have the authority to act.

Ms Eerkes provided members with a brief outline of the proposed changes, adding that she conducted extensive consultation during the development of this proposal.

During the ensuing dicussion surrounding this proposal, members provided a number of comments and questions, including, but not limited to: clarification regarding current concerns with the panel; concerns that the perception of fairness within these processes would suffer as a result of the proposed changes;

support for written reasons to continue to be provided; clarification regarding where on campus assistance is required; that these proposed changes provide more rights and protection than in any other legal forum; that there are various reasons why the University of Alberta Protective Services (UAPPS) will not proceed with an investigation; a suggestion for an editorial amendement.

Members agreed to the inclusion of a friendly amendement to ensure that written reasons will be provided.

THAT the GFC Campus Law Review Committee recommend to the GFC Executive Committee proposed changes to Section 30.5.2(6) of the Code of Student Behaviour: Appeal of Declining to Proceed with a Complaint, as submitted by the Office of Student Judicial Affairs (OSJA), and as contained within Attachment 1, as amended, to be effective upon final approval.
