MOTION: THAT the GFC Programs Committee, with delegated authority from General Faculties Council, approve the proposed Minors in Agricultural Food Policy and Global Health; Clothing, Textiles and Material Culture; Environmental Policy; and Family Science, as proposed by the Faculty of Arts, for inclusion in the 2025-2026 University Calendar.

EXECUTIVE SUMMARY:

The Faculty of Arts and the Faculty of Agricultural, Life and Environmental Sciences have developed four new minors for Arts students in the BA and the BA (Honors), based on programming in ALES.

The minors are:

Agricultural Food Policy and Global Health Clothing, Textiles and Material Culture Environmental Policy Family Science

Each minor is centred on a core of ALES courses. Students can add more courses from a list of courses offered by ALES, Arts, Native Studies, Nursing, Science, and St. Joseph's College.

Each minor contains a mandatory Indigenous content requirement.

This package contains an internal program proposal template for each minor followed by the letters of consultation and support, beginning with a letter of support from the Dean of ALES. The Calendar change request forms are at the end of the package.

Please note that many of the letters of consultation and support refer to more than one minor.

We are asking for implementation for Fall 2025.
