- A short 'executive summary' should be included within the UTA nomination package that explains the central objective, from a teaching perspective, of what the individual (nominated) team is attempting to do through their collective.
- For all nomination packages, regarding of the teaching award, members felt that it made sense to ask for back-to-back photocopying, thereby cutting down on the size of the material (in whole) and showing sensitivity to sustainability.

Members agreed these issues could be discussed further at its June 17, 2011 meeting.
