regarding procedural rules surrounding conflict of interest; support for the ranking mechanism utilized by the Committee; that this ranking method is utilized within other teaching award processes; whether the Committee ever elects to not award certain awards; clarification regarding the date and time of the adjudication meeting.

The Chair provided an update to members in regards to current nomination submissions and noted that they had declined from previous years.

The Chair reminded members about the upcoming adjudication meeting.
