P Oel, Councillor-at-Large, noted that as part of Faculty Club's outreach efforts to graduate students, they were trying to organize a "Pint of Science" night, similar to the structure of Nerd Nite events. He noted that the idea was to have some graduate students present their thesis for the interested lay public around a beer. He noted that for those interested in "Pint of Science" but intimidated by larger audiences, perhaps the smaller format of "Pint of Science" would be a good first step and added that interested parties could liaise with him at aoel@ualberta.ca.

Action Items, Elections, Appointments, Special Business, Updates

6. 2015-2016 GSA Audited Financial Statements

E Schoeck (GSA Executive Director and Financial Team Lead) and S Ficko (GSA President) presented the item and introduced the guest, T Gee (GSA Auditor, Collins Barrow LLP).

MOTION BEFORE COUNCIL: That the GSA Council **RECEIVE FOR INFORMATION** the 2015-2016 GSA Audited Financial Statements.

E Schoeck noted that the GSA, as per the requirements of the *Post-Secondary Learning Act*, required a yearly audit. She indicated that last year the GSA changed audit firms but kept the same auditor, one who understood the history and operations of the GSA. She also noted that, this year, the GSA had had two field auditors in the office for three days and that they had access to everything and asked a series of questions (although fewer than in previous years). She reported that, when the field auditors had concluded their work, she and the GSA President met with the auditors to discuss the results and so that all parties could sign off on the audit before it was taken to the GSA Budget and Finance Committee, the GSA Board, and GSA Council before onward transmission to the Board of Governors. E Schoeck next noted that the recommendations to management from the auditor were minimal; while the GSA has made significant progress, especially related to its budget and financial controls, it was important to keep improving and stay on track.

S Ficko further explained that after the auditor came to the office, the audit was presented to the GSA Budget Finance Committee and then was sent to GSA Board. She noted that T Gee, the GSA's auditor, attended both these meetings to explain the audit in-depth and answer any questions. S Ficko then introduced T Gee.

T Gee expressed that he was always delighted to present at these meetings and that he was an alumnus of the U of A MBA program. He then reviewed the audited financial statements and highlighted some main points. T Gee noted firstly that the first few pages were standard for an independent auditor's report and that they stated that the information presented was compliant with standards for not-for-profit organizations. He indicated that over the past three years the overall financial management of the GSA had really improved and that around the time when E Schoeck started as the ED, new processes were put in place. He added that the GSA needed to maintain these improvements. T Gee next noted that the overall position of the GSA had remained strong and that it had improved a bit over the past year. He noted that the Assets to Liability ration had improved and indicated that, ideally, not-for-profits have a 2:1 ratio and the GSA was not there yet but it was moving closer to this ratio every year. He also noted that in both 2015 and 2016 there was enough cash set aside to cover restricted funds.

T Gee next commented that the Statement of Operations for 2015 and 2016 saw a modest operating surplus and that the current year was a little bit better than the previous one. He noted that this was a good improvement from five years ago, when the GSA had operating deficits. He added that over the last few years there had been consistency and not a lot of volatility or surprises, which was positive T Gee then commented on the Statement of Change, noting that over the past few years some reserves had been established/further grown, such as the Legal Defense Fund, the Stabilization Fund, and the Human Resources Fund. He noted that the Legal Defense Fund needed to be increased as a lawsuit could be very expensive.

T Gee then noted that the Statement of Cash Flow showed a decrease due to investments the GSA made and that this represented moving money from one cash pocket to another cash pocket. T Gee also noted that the Operating Activities saw a pause in cash inflow. He added that the GSA was able to generate a positive cash inflow. T Gee concluded by stating that the GSA's financial position was good and, operationally, it was a good year.

T Gee opened the floor for questions. There were none.

On the topic of investments, E Schoeck added that the GSA used to have money held by the University in its Unitized Endowment Pool and that last year the University turned this money over to the GSA and that the GSA had invested it with the assistance of an investment manager and expected the returns to be at least as good if not better than when the funds were with the University.

7. GSA 2016-2017 Budget and Expenditure (Quarterly) Report

MOTION BEFORE COUNCIL: That the GSA Council **RECEIVE FOR INFORMATION** the GSA 2016-2017 Budget and Expenditure (Quarterly) Report.

E Schoeck presented the quarterly report and noted that the report only presented two months of expenditure. She added that this report was unavailable six years ago when the GSA did not have good financial reporting mechanisms in place. She also noted that for the past two or three years the GSA has been running a positive balance. She indicated that some lines of the budget were overspent while others were underspent but that the total evened out. She mentioned that one line that was underspent on was insurance as the GSA recently changed brokers and now had the same broker, who was based in Edmonton, for all policies (General Liability and Directors and Officers Liability). She noted that some of the lines that were overspent were the Awards Night line as, due to a last minute change in dates, two Awards Nights were occurring in the same fiscal year (so Awards Night was underspent in 2015-2016 but overspent in 2016-2017) and the IT line, as the GSA office had had a on-site review

and associated tasks in order to to raise this aspect of the GSA's operations to University minimal standards. She noted that there was a narrative attached to the report with further details for every line and introduced the other members of the Financial Team: Shirley Ball, GSA Accountant; Dorte Sheik, GSA Financial Manager; Heather Hogg, GSA Director of Operations; and Courtney Thomas, GSA Director of Services and Governance. She noted in closing that the financial team was always focused on the GSA's financial and organizational health. S Ficko added that the GSA 2016-2017 Budget and Expenditure (Quarterly) Report was reviewed by the GSA Budget and Finance Committee and the GSA Board.

MOTION: That the GSA Council **RECEIVE FOR INFORMATION** the GSA 2016-2017 Budget and Expenditure (Quarterly) Report. S Ficko **MOVED**. A Talei **SECONDED**.

8. Second Reading: GSA Rolling Budget and Business Plan: Proposed Changes to GSA Bylaw and GSA Policy

S Fenichel noted that this was the second reading of the proposed changes to GSA Bylaw. There were no questions.

MOTION: That the GSA Council, on the recommendation of the GSA Budget and Finance Committee and the GSA Board, **APPROVE** proposed changes to GSA Bylaw and GSA Policy to move from a five-year rolling budget and business plan to a three-year one, as noted in the attached double column document and effective upon the second reading by GSA Council in the case of GSA Bylaw and immediately in the case of GSA Policy. S Ficko **MOVED**. A Capello **SECONDED**.

9. GSA Council Elections

M DuVal (Administrative Chair of the GSA Nominating Committee) presented the item.

M DuVal explained that GSA Council was voting for a graduate student to sit on a Dean Selection Committee for two faculties, Education and Medicine & Dentistry. She noted that these vacancies were filled according to the General Faculties Council procedures for Dean Selection Committees so they were a little bit different than what GSA Council might be used to. She noted that the procedures stated that every department from each faculty was to select a nominee and submit that nominee for the election. She added that all nominees were invited to speak at GSA Council but, according to GSA practice, if one person could not attend to speak, no candidates would speak and that, as not all the nominees could attend, the nominees would not be invited to address GSA Council. T Nabe asked why that was GSA practice and M DuVal explained that, in the interest of fairness, if someone was not available to speak that nominee was at a clear disadvantage.

Reports

10. President

i. President's Report:

Members had before them a written report, which had been previously distributed on 15 July 2016. In addition, S Ficko stated that the first GSA roundtable discussion happened on July 11 and two graduate students attended. She noted that a exercise similar to the one GSA Council participated in at the last meeting had been held at the roundtable and expressed hope that more graduate students would attend the next roundtable on August 4.

S Ficko next noted that that there would be a forthcoming change in the assessment of Mandatory Non-Instructional Fees (MNIF) as the MNIF structure has been simplified and consolidated into new categories (Athletic and Recreation Fee, Student Health and Wellness Fee, and Student Academic Support Fee). She added that the new assessment system came with an increase in accountability and transparency (oversee by a newly created MNIF oversight committee) and that this restructuring would not change the amount of MNIFs paid.

Finally S Ficko reported that E Schoeck would be stepping down as the GSA Executive Director at the end of the summer. She noted that E Schoeck had a lot of knowledge and that it would be a big transition. She also noted that in the process of hiring a new Executive Director she had had lot of support and had reached out to past GSA Presidents. She noted that, after an interview with the GSA Board, it was determined that C Thomas, current GSA Director of Services and Governance would be hired as the new GSA Executive Director. She added that C Thomas would start in this position on September 1, 2015.

She also noted that the GSA had been approached to find a representative to serve on the Bookstore Advisory Committee and asked GSA Council members if they used the Bookstore and it what ways. She added that if they had any feedback about the Bookstore they could contact the GSA VP Student Services, A Talaei, at gsavpsse@ualberta.ca.

Members had before them a written report, which had been previously distributed on 15 July 2016. The report stood as submitted and, in addition, F Khodayari highlighted the Graduate Student Internship Program, which created internship opportunities for graduate students. He added that he suggested allowing graduate students to organize their own internship and that the advisor to the program, Andrea Spevak, liked the idea but, nonetheless, internships found by graduate students would be vetoed by the Faculty of Graduate Studies and Research. He mentioned that the maximum rate of compensation for internships in the program was \$25/hour.

Members had before them a written report, which had been previously distributed on 15 July 2016. The report stood as submitted.

14. Vice-President Labour

i. Vice-President Labour's Report

Members had before them a written report, which had been previously distributed on 15 July 2016. The report stood as submitted and, in addition, S van der Klein noted that she attended the Implementation Steering Committee of the Review of the University of Alberta's Response to Sexual Assault. She added that this review began in February and that, following this review, one committee was created to review the current policy regarding sexual assault and one was created to implement the other recommendations found in the report; the latter was the one she had attended. The mandate of this committee was to guide and oversee four working groups, each one aiming at one cluster of recommendations. She added that the working groups will need graduate students to serve on them and asked that if there were any graduate students interested in serving, they could contact her or M DuVal, Administrative Chair of the GSA Nominating Committee. N Prather asked how the University was positioned relative to other Universities when it came to responding to sexual assault and S van der Klein replied that the University was doing pretty good but there was always room for improvement.

15. Vice-President Student Services

i. Vice-President Student Services' Report

Members had before them a written report, which had been previously distributed on 15 July 2016. The report stood as submitted and, in addition, A Talaei noted that the current U-Pass agreement between the various municipalities and the University expired in August 2017 and that the municipalities have started negotiating a new agreement with the post-secondary institutions participating in the program and their respective students' associations. He noted that the municipalities' opening position for the new four-year agreement was presented as a cap on the fee for the first two years and then a slight increase in the fee in the next two years. A Talaei further noted that the University of Alberta subsidized the cost of the U-Pass for students and that this subsidy would have to be negotiated as the agreement governing it (between the GSA, the SU, and the University) also ended in August 2017 and that the subsidy might be lower. A Talaei added that he would keep GSA Council informed on the progress of both negotiations.

20. GSA Management

i. Executive Director's Report

Members had before them a written report, which had been previously distributed on 15 July 2016. It was noted that this was E Schoeck's last report to GSA Council as Executive Director. The report stood as submitted and, in addition, E Schoeck reported on the state of the GSA six years ago, noting that, as a historian, she believed in the importance of understanding the past. She noted that when she came to the GSA the organization was extremely disorganized and she had many discussions with then GSA President Roy Coulthard about budget, staffing and many other matters on the road to repairing the organization and its reputation. She noted that she was happy to report that the GSA was in much better shape now, with an excellent staff, a balanced budget, a good IT infrastructure, etc. She noted that even with all this progress, GSA Councillors needed to remain vigilant and to go out and vote for Directly-Elected Officers and participate in other ways. E Schoeck then introduced the current GSA office support members. She noted that she had known the incoming Executive Director, C Thomas, for a very long time and that C Thomas had a BA and MA from the U of A and a PhD from Yale and that she has been with the GSA since 2012 and had also worked in University governance. She added that the GSA would be in very good hands.

E Schoeck then thanked all the graduate students who worked to rebuild the GSA, especially R Coulthard, and all the graduate students that volunteered their time to make the GSA a great organization. She added that it had been a pleasure to work for the GSA and GSA Council warmly thanked E Schoeck with a round of applause.

Dear GSA Council Members,

September 16, 2016

Beginning in February of 2016, the GSA Governance Committee and the GSA Board have been involved in extensive discussions concerning the quorum (currently set at 14 voting members) of GSA Council. Some of you may recall that this matter was referred to the GSA Governance Committee by GSA Council early in 2016. For a brief history of these discussions, please refer to the attached Outline of Issue and double column document of proposed changes.

At the joint GSA Board and GSA Governance Committee meeting on August 3, 2016, members came to a consensus to recommend that quorum for GSA Council be increased to 30 voting members. The rationale behind this is set out in the attached double column document.

In arriving at this decision, both committees identified and discussed the potential risks inherent in increasing the quorum of GSA Council (such as the risk of not having quorum at crucial meetings such as when the budget or the Collective Agreement are considered). However, based on historical data concerning attendance, the provision currently in GSA Bylaw and the Standing Orders of GSA Council concerning the calling of Special Meetings (if, for example, quorum was not achieved and pressing business needed to be attended to before the next regularly scheduled meeting), and members' feelings that the current quorum of 14 was simply not high enough, and after much careful consideration, I am pleased that we have arrived at the suggested quorum of 30 members. As with any change to our Bylaws and Policies, we will continue to closely monitor (in this case) attendance levels at GSA Council on a regular basis and, should this increased quorum prove problematic, we will review this matter again.

At its February 22, 2016 meeting, GSA Council approved a Motion to refer the matter of the quorum of GSA Council to the GSA Governance Committee (GSA GC) and asked that the committee discuss potential changes. GSA GC discussed quorum and other matters at length during their February 29, April 5, and June 24, 2016 meetings. The GSA Board also discussed the matter at their meetings of June 29 and July 6, 2016. The GSA Board and the GSA GC then met jointly on August 3, 2016 and agreed to propose that quorum be set at 30 voting
	members. This proposal was agreed upon after extensive analysis of data related to GSA Council attendance over the past several years (summarized in the Outline of Issue associated with this item). The specific number of 30 was arrived at as follows:
	• The current number of voting seats on GSA Council is 86. However, GSA Board and GSA GC members agreed that Medical Sciences and Interdisciplinary Studies should be removed from the membership of GSA Council. This is because, as per GSA Bylaw, Part III, Section 2.1.3, the composition of GSA Council includes "one (1) graduate student elected from each department, faculty, or extra-departmental unit at the University that offers a graduate program." However, Interdisciplinary Studies is not a standalone department that offers a graduate program. Rather, it involves the combining of two or more academic disciplines into one activity (ie those in Humanities Computing or Religious Studies programs are a part of Interdisciplinary Studies but their programs (and these units have seats on GSA Council) are Humanities Computing or Religious Studies. Likewise, Medical Sciences is an umbrella of various departments. Medical Sciences is composed of seven departments, and each has a seat already on GSA Council. Medical Sciences is thus also not a stand-alone department that offers a graduate program. Finally, neither Interdisciplinary Studies nor Medical Sciences has ever had a representative on GSA Council (because they are not stand-alone departments that offer graduate programs and all their

	 When Interdisciplinary Studies and Medical Sciences are removed, the total number of voting seats is 84; however, a seat for the new graduate program in the Department of Women's and Gender Studies has been added (this new graduate degree program welcomed its first students this fall), taking the number of voting seats to 85. 30 constitutes 35% of the total number of voting seats (85). This percentage was felt to be broadly representative of the total number of seats on GSA Council (and certainly more so than the current quorum of 14), while at the same allowing for quorum not to be set at an overly high number that could impede GSA Council's ability to move important business matters (such as the GSA's budget) forward. Members also felt that it was better to use a fixed number for quorum, rather than a rolling percentage, so as to reduce confusion and the need to re-calculate quorum on a rolling basis. Additional Information: The Interdisciplinary Studies is unit that includes Humanities Computing and Religious Studies graduate programs while Medical Sciences is comprised of Obstetrics and Gynecology, Radiology and Diagnostic Imaging, Ophthalmology, Dentistry, Laboratory Medicine and Pathology, Medical Genetics, Pediatrics (please note that while the FGSR website lists eight programs, one of those listed is in fact a post graduate program).

Outside of school, I enjoy playing sports, travelling Canada and abroad, and exploring Edmonton with friends. I've also been involved with various

community and campus groups including Science Mentors, St. John Ambulance, U of A First Aid Responders, and the campus Golden Key chapter. I have also had an active voice on G.S.A. Council as Councillor-at-Large since October 2015. Together, my volunteer and leadership experience has shaped my outlook and refined critical analytical skills, which are useful specifically when reviewing and developing policies to enact positive change within institutions such as the University of Alberta.

Summary Resume

I am currently beginning my second and final year of my M.Sc. in Physiology with Dr. Greg Funk. I study the central rhythmic breathing center of the mammalian brain, also known as the preBötzinger Complex. I specifically examine how astrocyte-derived modulators, like adenosine, influence this region during development, which is critical in understanding how we respond to stimuli like hypoxia. This project is a continuation of my undergraduate honors thesis, but I have previous research experience in Physical Therapy (2010, HYRS) and in Laboratory Medicine and Pathology (2013-2014, Undergraduate Research). My interest in serving as a GSA Councillor-at-Large was to actively contribute to the Council and support the development of effective policies to support all graduate students at the University of Alberta. To date, I have had an active voice on Council and I believe I can further represent and speak for other students and councillors by serving on the G.S.A.'s Governance Committee. I am committed to working with other committee members to further a progressive mandate that will benefit all graduate students at the University of Alberta. Based on my current schedule, I do not foresee any time commitment conflicts that will interfere in fulfilling this role.

The cost of the Plan is increasing for 2016-2017. Premiums (insurance rates) are determined by the amount of "risk" (ie, cost associated with paying out claims) calculated for an individual or a group (in the GSA's case, a group, as it is a group coverage plan), using claims history information and specific information about that individual or group. As "risk" (ie claims/cost to the insurance company) goes up, premiums go up as well so that the insurer has a larger pool of money to draw from when it covers submitted claims, thereby minimizing their "risk" (which, as privately owned, for-profit companies, they are invested in doing). In general, the largest driver of the cost of a group Plan such as the GSA's is usage and claims. Essentially, the insurance business is predicated on building up a large reserve of money and hoping few claims are filed. However, when claims go up and that pool of money gets depleted, costs go up to replenish the pool of funds.

Increasingly large numbers of graduate students are using the GSA Health and Dental Plan; and it is good news that people are using this important service. However, increased usage does mean that the cost of the Plan has risen because the cost is based on the number and dollar amount of claims submitted. When more graduate students use the Plan by filing claims, the cost of the Plan increases overall.

Background on the history of the Plan:

- The Plan was established by referenda in 1994 (Dental) and 2003 (Health)
- It is designed to cover "extras" and to fill gaps in provincial basic healthcare (Alberta Health Services)
- The Plan is administered by the GSA's broker, Studentcare (since 2003), under the direction of the GSA Board and governed by GSA Bylaw and GSA Policy
- The GSA's insurance company is currently Desjardins Financial Services (since 2012); prior to that it was Sun Life Financial
- Over \$1.8 million in claims were paid to GSA members in 2015 (up from ~\$1.6 million in 2014)

How the fee is set annually and increases to the fee over the past few years:

- The GSA Board reviews data with Studentcare semi-annually, and then recommends fee and benefit changes to GSA Council annually
- GSA Council is responsible for final approval of the fee (except if it exceeds a 15% increase; this triggers a referendum) and benefit changes (eg in July 2014, GSA Council approved an increase to vision benefits)
- The fee and benefits are set annually in March/April based on ~6 months of claims data and previous trends
 to meet the U of A Board of Governors schedule to approve the collection of the fee in advance of the new
 academic year starting in September
- When the GSA switched insurers to Desjardins, a set fee for two years was offered (this was because, after many years of operating in the eastern provinces, Desjardins was trying to break into the business realm of the western provinces and were highly motivated)
- During this period the cost paid by graduate students did not increase but it was an artificial freeze as claims (and so the actual cost of the Plan) were increasing behind the scenes
- In 2014-2015, GSA Council (acting on the recommendation of the GSA Budget and Finance Committee and the GSA Board) agreed to maintain the fee at the same level as 2011-2012 by using the GSA Health and Dental Plan Reserve Fund (HDPRF) to cover increase this fund exists because, occasionally, after setting the fee, Studentcare negotiates a premium that is lower than expected. The GSA then banks the difference in the

HDPRF, a restricted fund governed by GSA Bylaw and GSA Policy that can only be used for health and dental purposes (ie to decrease a fee increase seen by members in a given year, or to increase coverage)

• In 2015-2016, GSA Council (acting on the recommendation of the GSA Budget and Finance Committee and the GSA Board) approved a total 11% increase to the fee (and maintaining the existing level of coverage), with graduate students paying 8% and the HDPRF being used to bridge the remaining 3%

The current situation:

In February of 2016 the GSA received early data on members' claims for 2015-2016. That data indicated a large increase in the number of claims, which means a commensurate increase in the cost. The GSA Board (tasked with oversight of the Plan), the GSA Budget and Finance Committee (whose mandate is to advise on all financial matters associated with the GSA), and GSA Council (represented by a graduate students from every department with a graduate program) discussed this matter extensively in March, April, and May. Rather than cutting benefits in order to keep the cost the same as 2015-2016, GSA Council voted to approve a 15% increase to the fee associated with the Plan for 2016-2017. The actual increase in the cost of the Plan was 17% but GSA Council also approved off-setting the amount paid by again graduate students by drawing down the GSA Health and Dental Plan Reserve Fund. The fee paid by graduate students for 2016-2017 will be \$492.95/year, an increase of 15% (or \$64.30/year) over 2015-2016.

In order to provide a snapshot of how use of the Plan and associated cost has expanded, please look at the below two tables.

Additionally, below are some quotes on roughly equivalent coverage (although not as comprehensive) offered by publicly available plans. All information was gathered off the respective plan websites. Please note that rates will differ based on age, etc and so **these are estimates only**; likewise, travel coverage is not included below, but 10 days of coverage, versus the 120 days in the GSA Health and Dental Plan, appears to be the norm. Finally, the coverage amounts of the GSA Health and Dental Plan do not include additional savings that can be achieved by utilizing the services of network providers who may give grad students a percentage discount on services. This information is offered to give a sense of how the cost and coverage of the GSA Plan compares to that of other plans.

GSA President Report to GSA Council for the September 26, 2016 Meeting

Dear Councillor Friends and Colleagues,

Crunch, crunch! I love the sounds made while walking through a pile of dry leaves at the time of year © As we haven't met in a little while, I want to say welcome to autumn, and welcome to a new school year! I hope everyone had an enjoyable, fun, relaxing, and productive summer, and are ready for a new year of research, teaching, and learning.

After getting back from my field research site in the NWT, I've hit the ground running in terms of meetings, committees and events to attend, participate in, and lead. We've had a ton of things going on at the GSA ranging from departmental orientations to events and receptions, to assisting grad students with issues of concern. I'll highlight a few key areas in my report, including the Health and Dental Plan review, labour consultation, and Collective Agreement education, and the VPs also talk about many of the other issues and items we've been involved with this month.

As many of you are aware, we have been doing a fairly comprehensive review of our Health and Dental Plan, at the request of Council this past spring. Over the summer, we discussed the feedback generated from the facilitated workshop and silent discussion in Council, the Roundtable sessions open to all graduate students that we hosted, and feedback received from individual graduate students who were unable to attend the Roundtables, at our weekly GSA Board meetings. After reviewing the feedback, Ali and I requested that our broker, Studentcare, ask our insurer, Desjardins, to provide us with quotes on four different plan options: a) a plan with less coverage and a lower cost than our current one, b) a plan with greater coverage and a higher cost than our current one, c) a two tiered plan with levels that have more and less coverage and cost than our current plan, and d) a three tiered plan with less, similar, and more coverage and cost than our current plan. Studentcare provided us with this information just in time for our first H&D Town Hall on September 12. At that meeting, I provided the attendees with background information on the H&D Plan, and then we went through a series of questions to discuss the type of plan and benefits that students would like to have. We'll be doing a similar exercise at Council this month, and then there will be a final opportunity for consultation with other graduate students at the September 30 Town Hall. While one plan will never fully satisfy everyone, I want to thank everyone who has participated so far for their thoughtful comments and suggestions. I'm hoping that by doing extensive consultation this year, the GSA will continue to offer a plan that meets the needs of graduate students and their families moving forward.

The second key area I've done a lot of work on is about the changes to existing labour legislation that are being brought forward by the provincial government. As a brief overview, in January 2015, the Supreme Court ruled that the right to strike is a fundamental right for public sector employees when collective bargaining negotiations break down. In many other jurisdictions, employment and labour relations within the post-secondary education sector have been contained within a labour relations code or legislation, but in Alberta, it has been governed under the *Post-Secondary Learning Act*. Due to this

more open-ended structure, collective bargaining processes are contained in GSA and Faculty Association collective agreements rather than in legislation, and have developed in an organic and collegial manner over many years. If negotiations do break down, the *PSLA* generally mandates a process of compulsory binding arbitration as a final step to resolve disagreements, though this has never been needed in GSA negotiations.

During the initial round of consultation last fall, the Alberta Graduate Provincial Advocacy Council (ab-GPAC), which is composed of members from the four research intensive universities with graduate programs, was consulted and responded that graduate students should be treated differently from other groups (non-academic staff, faculty associations) as many graduate students wear multiple hats (student, TA, RA, etc), that GSAs should retain the exclusive right to represent grad students, and that compulsory binding arbitration is a more effective tool for graduate students, as the potential economic gains from a strike were overshadowed by reservations about the effectiveness of a strike, the negative consequences to students, and the high potential to be locked out by the university. While it was initially agreed that the status quo would remain in place for graduate students, further legal advice by the government indicated that the status quo was not compliant with the Supreme Court ruling. As such, the government has embarked on a second round of consultation, beginning late August 2016, and continuing until October 17.

At this point, we are developing responses to submit to the government, both as individual GSAs and for ab-GPAC. A longer briefing document developed by the Labour Relations Committee of ab-GPAC, along with a series of questions and scenarios that people will be asked to complete and submit, is being developed with the intention of sharing it with all graduate students through a GSA Special Bulletin. If you would like to submit feedback directly to the government, they have developed a discussion guide and an online form to submit further feedback https://PSLALabourRelations.alberta.ca, and will also be hosting consultations on campus on Sept 29 from 3-5 pm or 7-9 pm in the Council Chamber https://exem.eventbrite.ca/e/registration-for-post-secondary-labour-consultation-sessions-edmonton-registration-27355466938. This is a very important topic, and I encourage you to investigate it further as you think about the pros and cons of these changes, how it can affect you directly and affect the other students in your departments and faculties, and as you consider any potential long term effects on future students.

The final area that I want to talk about (and Sasha will follow up on this), is about our new Collective Agreement (CA) that came into effect on September 1. This year, it was very beneficial that the CAs for the non-academic staff, the academic staff association, and the GSA were all approved at the same Board of Governor's meeting, as it has helped raise awareness across campus about our CA. Lack of awareness and knowledge has been a serious issue in ensuring compliance with the CA. Over the last few weeks, I'm very pleased to say we've informed over 1,800 grad students about the new CA at over 35 Departmental Orientations and the GSA Fall Orientation (and even more when one considers that the GSA also presented at the University Alberta International Orientation). In addition, I have had the opportunity to help educate ~100 senior administration and other University administrators about the new CA over the past few weeks. I presented a version of the presentation I gave in Council in May during the ratification vote at a Statutory Dean's Council, at the ALES Cabinet meeting, and at the

Graduate Program Administrators Committee. I'm very pleased that so many people are more aware, informed, and actively engaging with our CA.

As I mentioned at the July Council, Ellen Schoeck has stepped down as Executive Director as of the end of August, and I'd like to thank her once more for all her hard work since 2012 in helping the GSA become a stable and supportive organization for grad students. After much discussion and consultation to develop a process to hire a new ED, I'd like to congratulate and warmly welcome Courtney Thomas (former GSA Director of Services and Governance) into the Executive Director role, and hope everyone will take a few minutes to stop by the GSA office in Triffo Hall or before/after Council to do the same. As a final note, I want to thank my VPs for all their dedication over the past few weeks in helping new students navigate the University system and in their ongoing work on behalf of grad students. I'd also like to thank the GSA Office Team for all their hard work in preparing, coordinating, and implementing all the meetings and events that we attend and host on behalf of grad students.

Dear Council Colleagues,

I remember two years ago, on my first day on campus, when I heard that the U of A logo and its branding colors were green and gold. At that time I wondered why; but, after couple of days of walking around the campus and river valley, I was amazed by the magnificent views of golden trees and how they mixed with evergreens. And that was my "eureka" moment! I hope you all enjoy the start of this beautiful, colourful season too, and do well in all aspects of your life.

Typically, September is one of the busiest times in the academic calendar for both students and the University's administrative bodies. For me as GSA VP External, this month was full of energy and positivity. At the start of the month, as the other DEOs report, we went to several departmental orientations. These gave me a chance to talk to many new graduate students and welcome them to the University of Alberta and the GSA family. In these orientations, we also talked a little about the GSA, its resources and its core services for graduate students. Aside from these departmental orientations, the GSA held its fall orientation, at which we had chance to talk to more than 300 students at the Telus Center. Dear Council Colleagues,

Fall seems to have come to Edmonton while I was out of the country for a week. In Beijing, I couldn't do without shorts and slippers, back in Edmonton my scarf and gloves are again part of my biking outfit each morning. So I didn't only have to overcome a sleep jetlag, but also a true season jetlag!

As the other DEOs report, before I left, around the end of August, it was **orientation time**. It was good to see so many new students attending the orientation sessions of their department and also great to see a lot of new students at our own event in the Telus Centre. Departments differ quite a lot in how they inform students about their upcoming graduate studies, but luckily many of them asked for a short GSA introduction at their orientation. I hope that everyone that attended knows where and how to find us!

I have received many cases involving misunderstandings or misinterpretings of the **Graduate Assistant Collective Agreement** over the last couple of weeks. This year's changes got many departments confused and them handing out the new offer letters created some further confusion for recipients (and some follow up work for the GSA). If you have any concerns about your offer letter, even if you consider it a minor issue, just shoot me an email about it.

Regarding the mental health portfolio, September 12 was the University of Alberta's World Suicide

Prevention Day. The Days of Action Committee on which I have a seat handed out around 800 postcards to create awareness around suicide and suicide prevention. Across campus there were many other initiatives such as the Identify, Help, and Refer Students in Distress drop-in Workshop in SUB. I have also been continuing my work on the Sexual Violence Policy Committee, reviewing this policy coming up for implementation in the new year. Regarding this same area of work, Sarah and I attended the Forensic Experiential Trauma Interview, known as FETI, workshop. This two-day workshop was basically aimed at law enforcement officers who do interviews with sexual assault victims to collect evidence. The biggest problem discussed is that how an officer would normally ask questions won't necessarily trigger memories in a trauma victim, as during the trauma, the neural pathways that create memory are inhibited. Christopher Wilson was a really engaging speaker and trained us in the way you should approach a conversation/interview with a trauma victim. Although this is extremely valuable knowledge, I do hope we won't have to use it in the future!

That was September, hope you have had a great start in the new academic year. And as always, let me know if you have questions, feel free to contact me any time!

Orientations

GSA Speaker Report to GSA Council for September 26, 2016 Meeting

Dear GSA Councilors,

This month I am submitting a written report in order to advise on some recent changes to the membership of GSA Council. According to the GSA Bylaw, the *composition* (as distinct from the *membership*) of GSA Council includes "one (1) graduate student elected from each department, faculty, or extra-departmental unit at the University that offers a graduate program." Currently, there are two voting seats on GSA Council (one for Interdisciplinary Studies and one for Medical Sciences). Both Interdisciplinary Studies and Medical Sciences do not offer graduate programs in their names, but are instead comprised of individual departments that already have distinct seats on GSA Council. I quote here from the material that accompanies the proposal for increasing the quorum of GSA Council and encourage you all to refer to that material:

"The current number of voting seats on GSA Council is 86. However, GSA Board and GSA GC members agreed that Medical Sciences and Interdisciplinary Studies should be removed from the membership of GSA Council. This is because, as per GSA Bylaw, Part III, Section 2.1.3, the composition of GSA Council includes "one (1) graduate student elected from each department, faculty, or extra-departmental unit at the University that offers a graduate program." However, Interdisciplinary Studies is not a stand-alone department that offers a graduate program. Rather, it involves the combining of two or more academic disciplines into one activity (ie those in Humanities Computing or Religious Studies programs are a part of Interdisciplinary Studies but their programs (and these units have seats on GSA Council) are Humanities Computing or Religious Studies. Likewise, Medical Sciences is an umbrella of various departments. Medical Sciences is composed of seven departments, and each has a seat already on GSA Council. Medical Sciences is thus also not a stand-alone department that offers a graduate program. Finally, neither Interdisciplinary Studies nor Medical Sciences has ever had a representative on GSA Council (because they are not stand-alone departments that offer graduate programs and all their constituent departments or units are already represented with individual seats on GSA Council)."

Given this, Interdisciplinary Studies and Medical Sciences will be removed from the composition of Council without in any way impacting the representation of graduate students on GSA Council. Likewise, a seat for the new graduate program in Women's and Gender Studies has been added to the membership of GSA Council. I welcome any questions you may have on this matter, or any other matter involving GSA Council.

While many of you may already know me, September marks my first GSA Council meeting as Executive Director and I would like to take this opportunity to briefly introduce myself.

I never fail to be impressed by the level of engagement and enthusiasm manifested by members of this Council and the past four years that I have spent with the GSA have been both challenging and exceptionally rewarding ones. I am excited to step into the role of Executive Director and look forward to continuing in a new role with an organization that does important work on behalf of graduate students (and post-secondary education more broadly) and that has such an excellent reputation. As our Auditor communicated to you in July, it is important for the GSA to stay on track after years of rebuilding; I look forward to supporting the work of the GSA's elected leaders and also to maintaining that excellent reputation and organizational stability over time. To ensure a smooth transition, the former Executive Director, Ellen Schoeck, will remain part-time with the GSA on a temporary basis as a Director-at-Large.

Turning now to a snapshot of operational matters, the GSA office support team has spent the time since the last GSA Council meeting engaged with several matters, including:

- Planning and delivering, along with the Directly-Elected Officers (DEOs), the GSA's fall orientation (over 300 attendees, one of the largest turnouts yet)
- Ongoing support of the work of the GSA's Standing Committees
- Assisting the DEOs with delivering over 35 departmental orientations (this year we collaborated with FGSR to bring an FGSR rep to as many departmental orientations as possible to deliver a short, separate presentation)
- Planning, under direction from the GSA Board, for several fall GSA events (including a PD event and Unwind Your Mind Coffee Breaks, for which we secured grant funding)
- Following on the GSA's IT upgrade over the summer (reported on previously by Ellen), exploring options associated with a service agreement concerning the maintenance and security of our IT structure
- Assisting several individual graduate students on a range of issues
- Supporting the GSA Board with its comprehensive review of the GSA Health and Dental Plan and development of the 2016-2017 GSA Board Strategic Work Plan
- Assisting the DEOs with the ongoing review/renegotiation of various agreements (including U-Pass and TDIMM)
