- Use Times New Roman 12 point font, single-spaced (regular, minimum 12-pt.)

**3) Applicant CV**

- The applicant's CV can be any format

**4) Supervisor Statement of Support**

- On institution letterhead and signed by the supervisor
- One letter maximum; for co-supervision, either the supervisor or the co-supervisor may provide one letter but not both.
- To be included with the full application (does not have to be emailed to GPS separately)
- This is in addition to the three letters of reference

**5) Copy of Fellowship Competition Results (if applicable)**

- Copy of feedback and/or ranking from any competitions that you applied to previously for the same project, if available (e.g., CIHR competition results)

**6) Copy of Doctoral Degree Certificate**

- If the degree certificate is not yet available, written confirmation from the Graduate School or Registrar of the university that all the degree requirements have been met and that the doctoral degree is forthcoming
- If the degree requirements have not yet been met, but you are expected to do so within 6 months of the application submission deadline, written confirmation from your supervisor/department of the expected date all degree requirements will be fulfilled

**Additional Documents Required: Three Confidential Letters of Appraisal**

- All letters of appraisal must be signed by the appraiser and be on institutional letterhead (electronic signatures are acceptable). They should contain a substantive evaluation of your ability and not be merely testimonials, as the fellowships are intended primarily for those who are seeking to establish themselves in their chosen field
  - **Only have three appraisals sent.** Any additional letters will be removed prior to the competition
  - Applicants are responsible for supplying their referees with the documents necessary for them to write their respective letters.
  - Applicants should contact their referees well in advance of the application deadline date. It is the applicant's responsibility to follow up with referees to ensure the assessments are submitted in sufficient time prior to GPS's deadline. **GPS will not follow up regarding missing reference letters.**
  - Applicants are to instruct referees to request Award Services to confirm receipt of their letters upon email submission.
- Must not include a letter from the proposed supervisor (or co-supervisor) as the Statement of Support is already provided
- As these letters are confidential, they must be submitted directly by the referees via email to [grad.awards@ualberta.ca](mailto:grad.awards@ualberta.ca) and have them indicate that it is for the Alberta Innovates Postdoctoral Recruitment Fellowship competition. Letters submitted by the applicant will not be accepted.
