

## How to Submit an Academic Standing Appeal in the Faculty of Science

The following information directly relates to the [Faculty of Science Academic Appeals Policy](#).

### Guidelines for Appeals

Your appeal letter must include your first and last name, your student ID, and your signature. It must also indicate the decision being appealed, the ground(s) for your appeal, any evidence to support the ground(s) and the remedy sought. All relevant information must be disclosed in the initial appeal and appeals that are not submitted in full by deadline will not be considered.

### Required to Withdraw

If your Academic Standing letter indicated you were **Required to Withdraw** (RTW) (less than 2.0 GPA), submit your appeal to the Associate Dean (Undergraduate) at <https://forms.gle/NHprwoaoTN47jgHR6>

### May Not Continue

If your Academic Standing letter indicated you were **May Not Continue** (MNC) (GPA of 2.0 or higher), submit your appeal to the Department responsible for your program (refer to chart below for contact information).

If you are registered in an **After Degree** program or the **BSc (Specialization in Science and Education)/BEd (Secondary)** Combined Degrees Program submit your appeal to the Associate Dean (Undergraduate) directly at <https://forms.gle/NHprwoaoTN47jgHR6> (not to the Department).
